Review of the 2022 Posting for Paramedic Testing

Chief Anderson stated that the District would like to request the posting for paramedic testing. He further explained that the testing process is open to current EMTs who would like to become a Paramedic. Potential candidates must successfully pass paramedic school and complete the FTO process before they will be promoted to the rank of Paramedic. Chief Anderson stated candidates will take a written test and participate in an interview process. There have been no changes to what has been previously done, except the addition of the 'Equal Pay for Equal Work Act of 2021'

verbiage that will be discussed at the next meeting. Attorney Ross stated that he feels comfortable and supports the wording, and he will provide an extensive review at the next meeting.

Chief Anderson indicated that a meeting on or around March 15 will be scheduled to certify the Lieutenant Promotional Eligibility list and to also discuss the Captain promotional process.
