paramedics passed and are on the attached Paramedic Hiring Eligibility List. Chief's Interviews will be conducted the week of February 14th. Chief Anderson believes all of the paramedic candidates on the hiring list are qualified; however, if necessary, Chief's Interviews will be conducted with the established EMT Hiring Eligibility List as well.
